## 1. Product profile

## 1.1 General description

Planar passivated sensitive gate four quadrant triac in a SOT186A (TO-220F) "full pack" plastic package intended for use in applications requiring high bidirectional transient and blocking voltage capability and high thermal cycling performance. Typical applications include motor control, industrial and domestic lighting, heating and static switching. This sensitive gate "series E" triac is intended for gate triggering by low power drivers and microcontrollers.




Fig. 1. RMS on-state current as a function of heatsink temperature; maximum values




Fig. 2. RMS on-state current as a function of surge duration; maximum values




Fig. 3. Total power dissipation as a function of RMS on-state current; maximum values





Fig. 4. Non-repetitive peak on-state current as a function of the number of sinusoidal current cycles; maximum values





Fig. 7. Normalized gate trigger current as a function of junction temperature






Fig. 8. Normalized latching current as a function of junction temperature






Fig. 11. Normalized gate trigger voltage as a function of junction temperature


