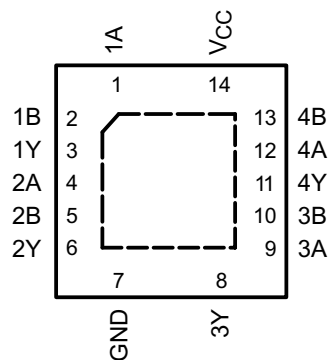

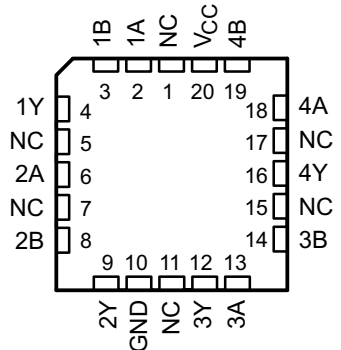

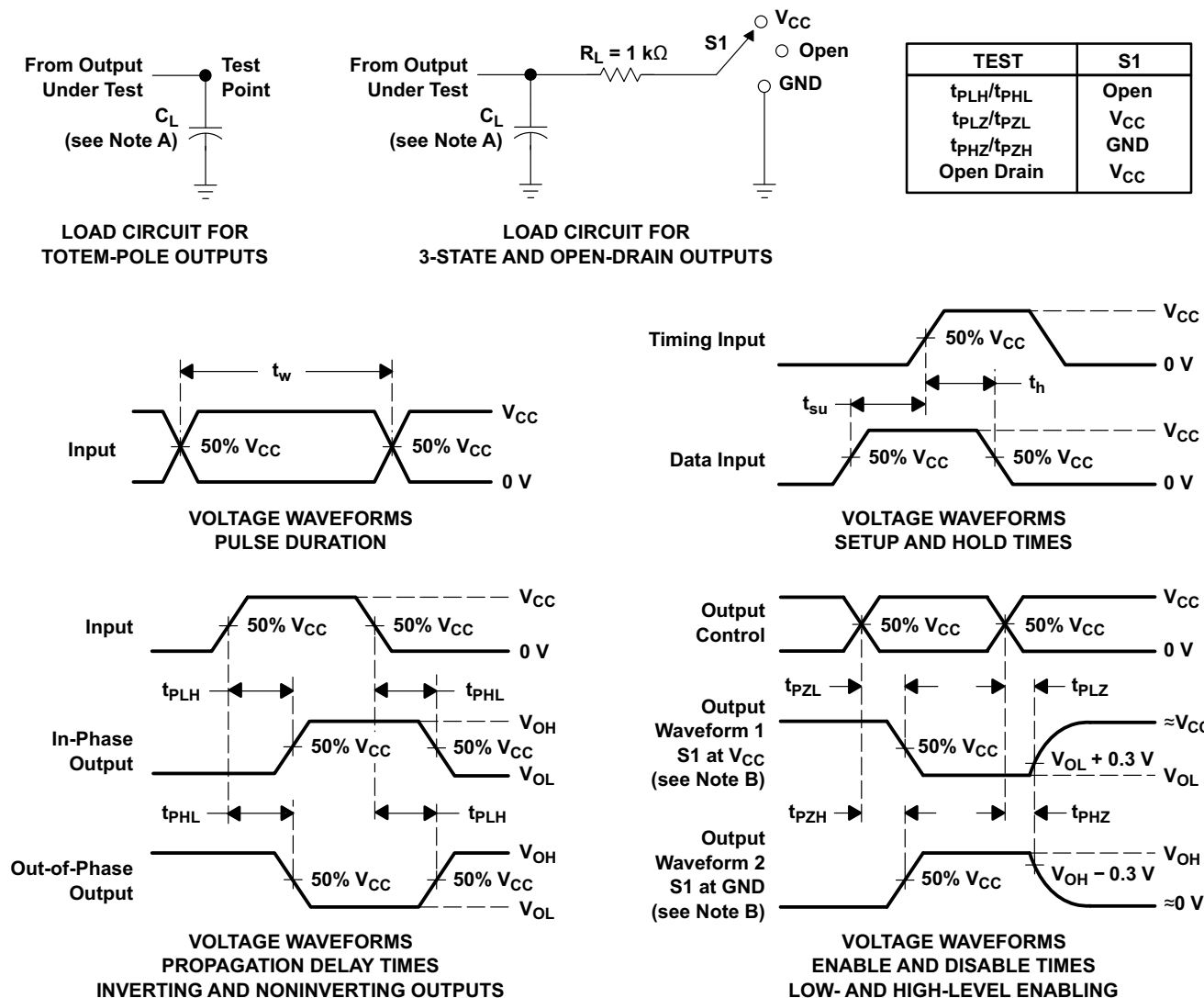

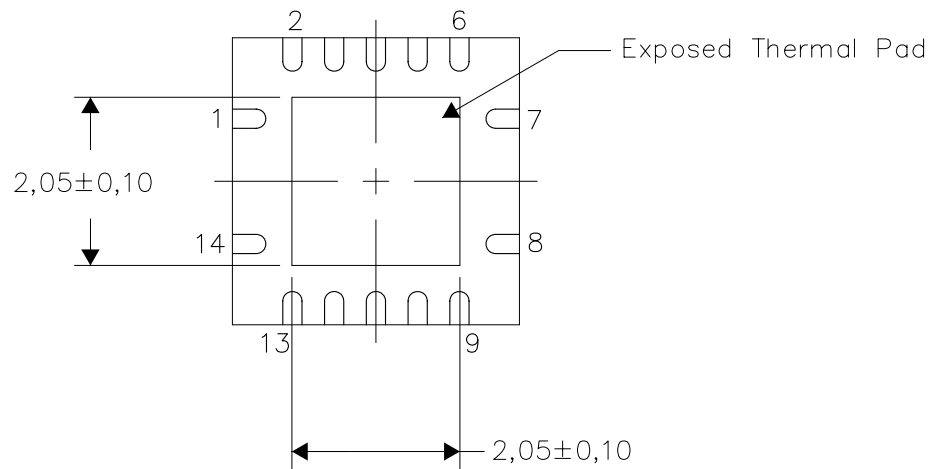

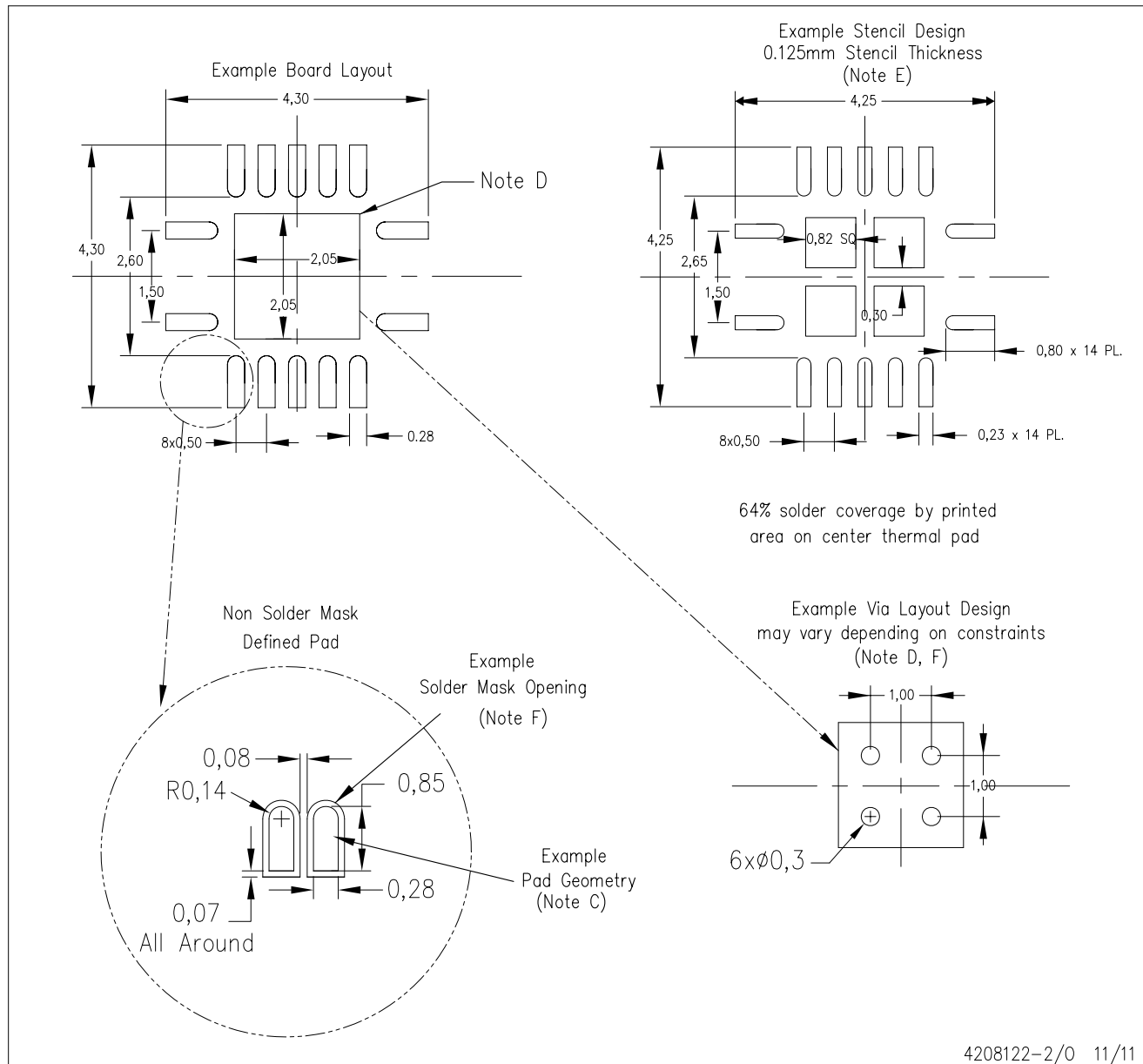
Exposed Thermal Pad Dimensions
