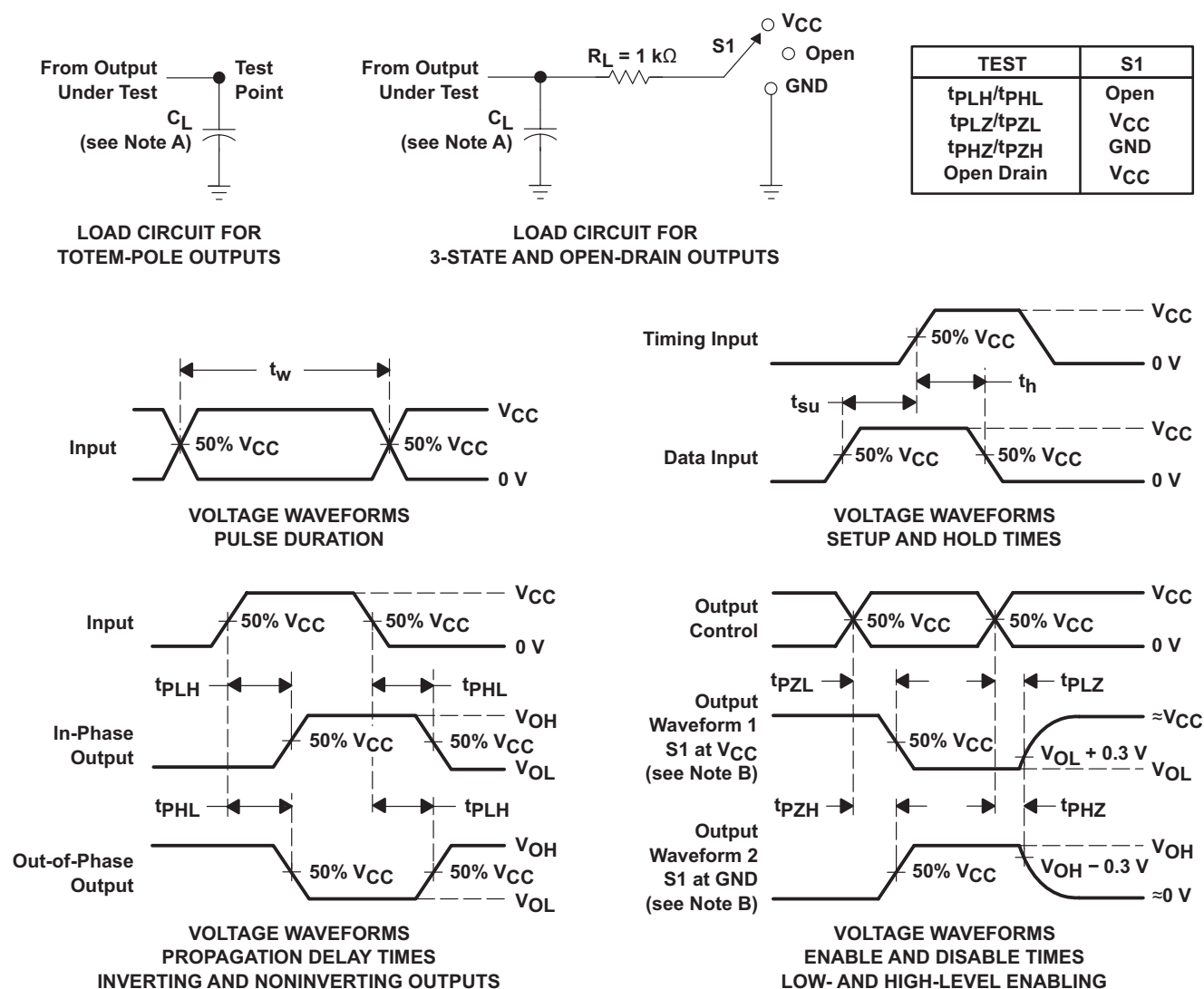

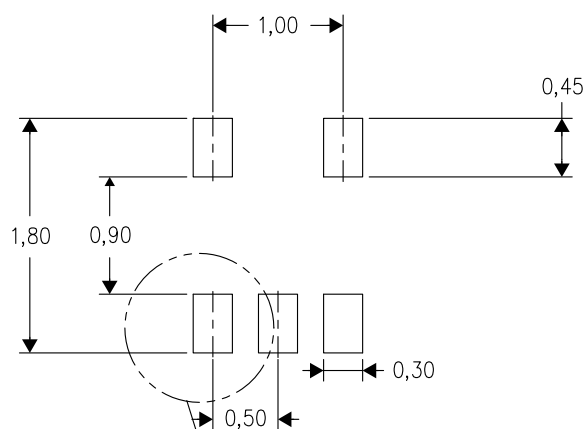

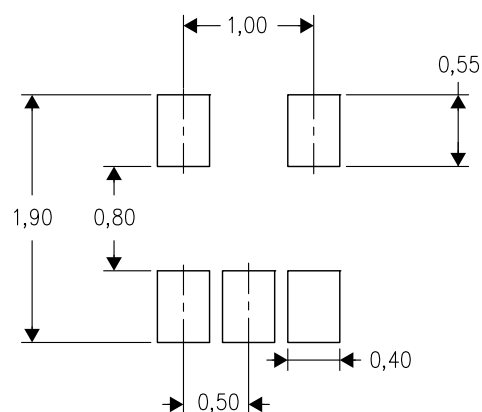

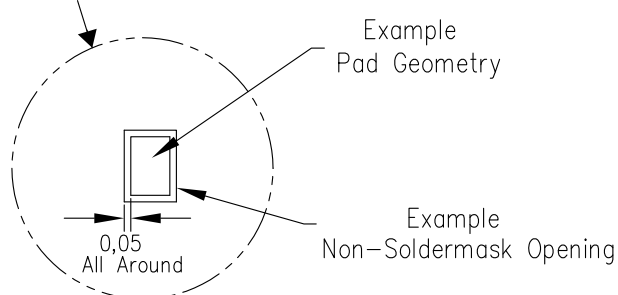
Example Board Layout
